Page 2, Under COMMITTEES stating Members in good standing who have served on a committee for one year and participated in club activities for more than 2 years will be considered for club committee chairs.

Page 3, Under CLUB OPERATIONS COMMITTEE: Eliminating "The Chair must have 5 consecutive years of service or previously served as an officer before being considered for the committee."

Additionally, on Page 3 under MEETING POLICY, I move to eliminate the paragraph as it stands \& replace. Meetings will be held on second Mondays of the months according to the schedule presented by the board of directors each year. The hostess for each meeting will choose the time and may decide on food service for a social time following the business portion of the meeting.

The Board along with the committee chairs will have a meeting in January to pass on documents to the new officers and committee chairs, develop a budget and discuss activities for 2019.

The six meetings planned for 2019 will be: February 11, April 8, June 10, August 12, October 14 and December 9. Mary Ann will host the meeting at her home on February 11.
